The Western States Water Council and the Native American Rights Fund will hold their fourteenth Symposium on the Settlement of Indian Reserved Water Rights Claims on August 25-27, at the Peppermill Resort in Reno, Nevada. Session topics will include: Negotiation of Indian Water Rights Claims - the Basics; The Role of Technicians in Negotiations; How Negotiations Bind Larger Groups; Securing Funding for Settlements; The Administration's Settlement Policy; and Getting Settlement Legislation Through Congress. The Symposium will begin on Tuesday, August 25, at 8:30 a.m. and continue throughout the day, with an evening reception. Discussions will continue through the morning of August 26, followed by a review of the Pyramid Lake Paiute Tribe's settlement and a field trip to view the settlement features along the Truckee River and a dinner hosted by Tribe at Pyramid Lake 40 miles from Reno. The Symposium will conclude on August 27 at noon after a morning discussion panel. Each attendee will receive meeting materials. ### **Hotel Accommodations:**

The Peppermill is holding guest rooms for the nights of August 24, 25, and 26 for the Western States Water Council at two offered rates available on a first-come, first-served basis. There are 50 rooms in the Peppermill North Tower at a rate of \$59+ per night and 39 rooms in the Peppermill Tower at a rate of \$89+ per night. Please note an additional Peppermill Resort Fee of \$15 per room per night will apply. The Resort Fee includes internet access in all public areas, sleeping rooms, and the Internet Cafe, complimentary business center access, incoming and outgoing faxes up to 5 pages, in-room coffee makers, use of the health club, pool, valet, access to the parking garage and surface parking, concierge, and shuttle service to and from the airport.

Reservations are subject to availability at the time of booking, and room rates will be honored, based on availability on a first-come, first-served basis. The Group Cut-Off Date is July 23, 2015.

The hotel has no obligation to provide room nights beyond those contained in the room block, however they will honor the group rate for early arrivals and late departures up to three days based on availability. Check-out time is 11:00 am on the day of departure.

### **Transportation:**

Fly into the Reno-Tahoe International Airport, which is located just 10 minutes from the Peppermill. The Peppermill offers complimentary shuttle service to and from the airport. The hotel also has complimentary valet and self-parking, as well as on-site car rentals.
