The Native American Rights Fund and Western States Water Council announce their sixteenth biennial Symposium on the Settlement of Indian Reserved Water Rights Claims. Session topics will include: Negotiation of Indian Water Rights Claims - The Basics; The Role of Technicians in Negotiations; How Negotiations Bind Larger Groups; Water Planning: Scarcity and Collaboration; The Administration's Settlement Policy; and Settlement Legislation: Getting Bills Through Congress.

The Symposium will begin on Tuesday, August 13, at 8:00 a.m. with a preliminary session on Western Water Law and Indian Reserved Water Rights and continue throughout the day, with an evening reception. Discussions will continue through the morning of August 14, followed in the afternoon by a presentation of the San Luis Rey Tribe's Water Rights Settlement. The Symposium will conclude on Thursday morning, August 15. A cultural event is also planned. Each attendee will receive meeting materials.

### **HOTEL ACCOMMODATIONS:**

The Harrah's Resort Southern California is holding a block of guest rooms for the nights of August 12-14. Reservations are subject to availability at the time of booking, and room rates will be honored, based on availability. All reservations must be guaranteed with a deposit for the first night's guestroom and tax charge.
